Invitation to Bid for Drilling of One (1) Exploratory/ Production Well in Brgy. San Pablo, Castillejos, Zambales

1. The **Castillejos Water District** through the **Corporate Operating Budget 2025** intends to apply the sum of **Two Million Eight Hundred Thousand (Php2,800,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Drilling of One (1) Exploratory/ Production Well in Brgy. San Pablo, Castillejos, Zambales**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Castillejos Water District** now invites bids for the above Procurement Project. Completion of the Works is required **sixty (60) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Castillejos Water District Main Office** and inspect the Bidding Documents at the address given below from **Monday to Friday from 8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 04 to 26, 2025 not later than 11:00 AM** from given address and website/s below, **in the amount of Five Thousand Pesos (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *to be presented in person*.
6. The **Castillejos Water District** will hold a Pre-Bid Conference¹ on **February 13, 2025, 2:00 PM** at **CSWD Main Office Conference Room, Brgy. Nagbunga, Castillejos, Zambales**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat **through** manual submission at the office address as indicated below on or before **11:00 AM, February 26, 2025**. Late bids shall not be accepted.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **February 26, 2025, 2:00 PM** at the given address below:

Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Castillejos Water District** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
